Watkins Manufacturing Corporation (“Watkins”) warrants to the original consumer purchaser (“you”) the following about your new Utopia Series spa, when purchased from an authorized dealer/service provider (“dealer”).

**10** **YEAR NO LEAK SHELL WARRANTY**  
Watkins warrants against water loss due to defects in the Utopia series spa shell for ten years.

**7** **YEAR SHELL SURFACE WARRANTY**  
Watkins warrants the acrylic surface material of the Utopia Series spas to be free from defects in materials and workmanship for seven years. This warranty does not cover damage to the shell surface that is cosmetic in nature and does not impact the integrity of the spa.

**5** **YEAR NO LEAK PLUMBING WARRANTY**  
Watkins warrants the Utopia Series spas against leaks caused by defects in manufacturing and workmanship for five years. This warranty specifically covers leaks from the wall fittings, jet fittings, internal plumbing, internal glue joints, drains, hoses, and all bonded parts.

**5** **YEAR COMPONENT WARRANTY**  
Watkins warrants the electrical components, pump(s), and other Utopia Series spa components against defects in materials and workmanship for five years. Some parts, most of which can be changed out without the use of tools, such as filter cartridges, filter lid, spa pillows, cover locks, and Freshwater salt cartridges are not included in this warranty, but are warranted to be free from defects in materials and workmanship at the time of delivery. Spa covers, Freshwater salt controller and other spa accessories are specifically excluded from this warranty, although they may be covered under other warranties. Please check with your Caldera® dealer for details.

**5** **YEAR ENERGYPRO™ HEATER WARRANTY**  
Watkins unconditionally warrants the EnergyPro heater to be free from defects in materials and workmanship for five years. This warranty defines unconditional, with the exclusion of commercial or industrial use, and improper installation, as warranty coverage without exception provided that the component has failed to operate properly within the spa's system.

**5** **YEAR ECOTECH™ PLUS CABINET WARRANTY**  
Watkins warrants the EcoTech Plus spa cabinet to be free from defects in materials and workmanship for five years. This warranty specifically covers the cabinet's structural integrity, including assembly. Fading and weathering of the surface may naturally occur over time and are not considered defects. Refer to the spa Owner's Manual for proper care and maintenance instructions.

**3** **YEAR ULTRAMASSEUSE™ SYSTEM WARRANTY**  
Watkins warrants the factory-installed UltraMasseuse control system to be free from defects in material and workmanship for three years. The pressureswitch and cable are warranted for one year.

**2** **YEAR LED LIGHTING SYSTEM WARRANTY**  
Watkins warrants the factory-installed LED light assemblies which consists of all lights within the spa to be free from defects in materials and workmanship for two years.

**2** **YEAR SOUND SYSTEM WARRANTY**  
Watkins warrants the factory-installed wireless sound system, which includes the stereo, wireless components, speakers and amplifier to be free from defects in materials and workmanship for two years.

The following applies to all of the warranties listed:

### EXTENT OF WARRANTY

This warranty extends only to the original consumer purchaser of the Caldera spa when purchased and originally installed within the country of purchase or, in the case of spas purchased in the European Union (“EU”), when originally installed within the EU. This warranty begins on the date of installation of the spa, but in no event later than one year from the date of purchase. This Caldera® spa warranty terminates upon

any transfer of ownership or if the spa is installed or relocated outside the boundaries of the country of purchase or, in the case of spas purchased in the EU, if the spa is installed or relocated outside the EU, prior to the expiration of the warranty period.

### WARRANTY PERFORMANCE

To make a claim under this warranty, contact the dealer where you purchased your spa. In the event you are unable to obtain service from the dealer, please write Watkins at 1280 Park Center Drive, Vista, California, 92081, USA Attn: Customer Service Department or call +1 760 598 6300 or via e-mail, [customerservice@watkinsmfg.com](mailto:customerservice@watkinsmfg.com). You must give Watkins, and/or your dealer written notice of any warranty claim, along with a copy of your original purchase receipt indicating the date of the purchase, within thirty (30) days of the time you discover the claim. Watkins reserves the right to inspect the malfunction or defect on location.

Watkins or its Authorized Service Agent will repair any defects covered by this warranty. Except as described herein, you will not be charged for parts and/or labor necessary to repair the spa for defects covered by this warranty. In some cases, the servicing dealer may charge you a reasonable repairperson travel/service charge that is not covered by this warranty. Please contact your dealer for information regarding any such charges.

Any and all additional costs including, shipping, delivery, set-up, installation and/or disposal charges, will be the sole responsibility of the spa owner.

### LIMITATIONS

Except as described above, this warranty does not cover defects or damage due to normal wear and tear, improper installation, alteration without Watkins prior written consent, accidents, acts of God, misuse, abuse, commercial or industrial use, use of an accessory not approved by Watkins, failure to follow the spa's Owner's Manual, failure to follow proper care and maintenance instructions or repairs made or attempted by anyone other than an authorized representative of Watkins. Alteration includes, but is not limited to, any component or plumbing change, or electrical conversion.
