### Inhalation

# **SECTION 3 - COMPOSITION/INFORMATION ON INGREDIENTS**

# **SECTION 4 - FIRST AID MEASURES**

#### **General Information:**

# **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles.
