Watkins Manufacturing Corporation ("Watkins") warrants to the original consumer purchaser ("you") the following about your new Vacanza Series spa, when purchased from an authorized dealer/service provider ("dealer").

YEAR NO LEAK SHELL WARRANTY
Watkins warrants against water

Watkins warrants against water loss due to defects in the Vacanza series spa shell for five years.

YEAR SHELL SURFACE WARRANTY
Watkins warrants the acrylic or UHMWPE (ultra high molecular weight polyethylene) surface material of the Vacanza Series spas to be free from

polyethylene) surface material of the Vacanza Series spas to be free from defects in materials and workmanship for two years.

YEAR NO LEAK PLUMBING WARRANTY

Watkins warrants the Vacanza Series spas against leaks caused by defects in manufacturing and workmanship for two years. This warranty specifically covers leaks from the wall fittings, jet fittings, internal plumbing, internal glue joints, drains, hoses, and all bonded parts.

YEAR COMPONENT WARRANTY
Watkins warrants the electrical components, pump(s), and other Vacanza Series spa components against defects in materials and workmanship for two years. Some parts, most of which can be changed out without the use of tools, such as filter cartridges, filter lid, spa pillows, and cover locks are not included in this warranty, but are warranted to be free from defects in materials and workmanship at the time of delivery. Spa covers and other spa accessories are specifically excluded from this warranty, although they may be covered under other warranties. Please check with your Caldera® dealer for details.

YEAR HI-FLOW HEATER WARRANTY
Watkins warrants the factory-installed Hi-Flow heater in the Vacanza series spa to be free from defects in material and workmanship for two years. This warranty does not cover commercial or industrial use spas or spas that have been improperly installed.

YEAR ECOTECH™ CABINET WARRANTY

Watkins warrants the EcoTech cabinet to be free from defects in materials and workmanship for two years. This warranty specifically covers the EcoTech cabinet's structural integrity including the material and assembly.

The EcoTech cabinet's cosmetic finish is warranted to be free from defects in materials and workmanship at the time of initial delivery. Fading and weathering of the surface may naturally occur over time and are not considered defects.

YEAR LED LIGHTING SYSTEM WARRANTY
Watkins warrants the factory-installed LED light assemblies which consists of all lights within the spa to be free from defects in materials and workmanship for two years.

YEAR SOUND SYSTEM WARRANTY
Watkins warrants the factory-installed wireless sound system, which includes the stereo, wireless components, speakers and amplifier to be free from defects in materials and workmanship for two years.

The following applies to all of the warranties listed:

EXTENT OF WARRANTY

This warranty extends only to the original consumer purchaser of the Caldera spa when purchased and originally installed within the country of purchase or, in the case of spas purchased in the European Union ("EU"), when originally installed within the EU. This warranty begins on the date of installation of the spa, but in no event later than one year from the date of purchase. This Caldera® spa warranty terminates upon any transfer of ownership or if the spa is installed or relocated outside the boundaries of the country of purchase or, in the case of spas purchased in the EU, if the spa is installed or relocated outside the EU, prior to the expiration of the warranty period.

WARRANTY PERFORMANCE

To make a claim under this warranty, contact the dealer where you purchased your spa. In the event you are unable to obtain service from the dealer, please write Watkins at 1280 Park Center Drive, Vista, California, 92081, USA Attn: Customer Service Department or call +1 760 598 6300 or via e-mail, customerservice@watkinsmfg. com. You must give Watkins, and/or your dealer written notice of any warranty claim, along with a copy of your original purchase receipt indicating the date of the purchase, within thirty (30) days of the time you discover the claim. Watkins reserves the right to inspect the malfunction or defect on location.

Watkins or its Authorized Service Agent will repair any defects covered by this warranty. Except as described herein, you will not be charged for parts and/or labor necessary to repair the spa for defects covered by this warranty. In some cases, the servicing dealer may charge you a reasonable repairperson travel/service charge that is not covered by this warranty. Please contact your dealer for information regarding any such charges.

LIMITATIONS

Except as described above, this warranty does not cover defects or damage due to normal wear and tear, improper installation, alteration without Watkins prior written consent, accidents, acts of God, misuse, abuse, commercial or industrial use, use of an accessory not approved by Watkins, failure to follow the spa's Owner's Manual, or repairs made or attempted by anyone other than an authorized representative of Watkins. Alteration includes, but is not limited to, any component or plumbing change, or electrical conversion.
